was great fun to see the 245 relatives, friends and neighbors who attended the celebration in our family's hometown. When I think of my personal heroines, Aunt Louise ranks up there with Amelia Earhart, Sally Ride and many other women who have provided inspiration.

We Zontians have an opportunity to inspire the women who benefit from our advocacy, service, scholarships and involvement. Although women today are busy juggling family, career and personal development, opportunities to become involved in our communities and the world give us a sense of purpose and accomplishment. #### Wahpeton-Breckenridge



Human slavery comes down to money

The Zonta Club of Breckenridge Wahpeton, North Dakota State School of Science and the Three Rivers Crisis Center sponsored Patrick Atkinson from the God's Child Project February 6, 2013. The message he relayed was

how human trafficking is a very real problem in the world

Atkinson spoke about the number of run aways from the Dakota and Minnesota who will go to bigger cities, Fargo and Minneapolis, and from there all the way to possibly even New York City. "There are 100,000 child prostitutes working in the United States right now. It's profit 101."

He talked about how human trafficking affects Americans who travel abroad and people around the world. Atkinson said 16,500 American children and women disappear into the international markets every year. In addition, 21,000 foreign victims are brought into the United States every year.

#### **Kansas City II**



On March 8, KC II Zontians Jan Armstrong, Marilyn Curtis and Janet Kannard distributed three dozen roses to the women working at the Southwest Boulevard Family Health Care Services of Greater Kansas City (Family Health CARE). Family Health CARE is a non-profit safety net clinic with services provided on a sliding scale for those who do not have insurance. The clinic's goal is to improve the health of their neighbors by providing comprehensive health care and supportive services, including a fitness center and a legal department to assist clients with legal issues.

During the visit, we got a tour of the facilities and were reminded how much the facility has expanded since our first visit several years ago.

Dr. Sharon Lee, Assistant Clinical Professor of Medicine at the University of Kansas and Founder & Director of the Southwest Boulevard Family Health Care clinic, spoke with us briefly after the tour. In 1989, Dr. Lee formed the Kansas City HIV Women's Coalition, as well as the Permanency Planning Project of Kansas City, KS, which provides services and assistance to AIDs orphans.

Dr. Lee is truly an inspiration to the community and KC II Zontians were proud to honor her and her colleagues on Zonta Yellow Rose Day.

# International Women's Day Remarks: March 8: Zonta Rose Day

Thank you for including Zonta in the program and the opportunity to tell you about ZONTA International and its significance in today's celebration. The yellow Rose represents Zonta's emblem and in conjunction with International Women's Day, March 8 has been designated Zonta Rose Day.

In the five minutes that has been allotted for this part of the program, let me give you the elevator talk about Zonta International, since most of you are more familiar with Rotary, the Lions and Kiwanis, most have not heard of Zonta.

\* The origin of the word ZONTA is from the language of the Sioux Indian to symbolize the combined qualities of honesty, trust, inspiration and the ability to work together for service and world understanding.

Founded in Buffalo NY in 1919, it was inspired by 5 women after attending a social meeting of the KIWANIS (an all male service club); established for women in business and professions to standardize and disseminate business principles and to provide service to humanity. Charter president was Marian de Forest, a playwright and newspaper critic.

\*current tag line adapted by the organization: To uphold the Status of Women Worldwide; 33,000 members in 64 countries – North America, Latin America, Africa, Europe and Asia.

Although the United Nations established International Women's Day only in 1977 to celebrate the rights of women and international peace; its history stretches back to the early 1900s when women's organizations used the day to rally support for their causes: from the universal suffrage movement to the protest of poor working conditions.

Since 1919, Zonta International has supported international service projects that seek to improve the legal, political, economic, education, health and professional status of women around the world, including among others:

- preventing the practice of female genital circumcision in Burkina Faso
- preventing violence against women in India
- eliminating maternal and neonatal tetanus in Nepal
- preventing human trafficking in Bosnia and Herzegovina
- reducing obstetric fistula in Liberia

**Zonta's International Service Funds** support the United Nations and since 1923 its has provided more than \$11 million to UN agencies to support projects that have improved the lives of more than two million women in 37 countries.

- UNICEF \$500.000 preventing mother -to-child transmission of HIV in Rwanda
- UN Women \$ 700.000 -for gender equality and empowerment of women
- UN Population Fund \$ 500,000
- UN Women \$430,000 UN trust fund to end violence against women (ZISVAW)

#### **Educational Awards Programs**

1. To Honor Amelia Earhart, a Zontian from Atchison, KS, an AE Fellowship has been established in 1938 to encourage women in aerospace sciences and engineering.

1,368 Fellowships have been awarded to a diverse group of women representing 68 countries totaling \$8 million.

- 2. Jane M . Klausman Women in Business Scholarships, established in 1998, for women pursuing undergraduate or master's degrees in business management. 275 recipients from 42 countries (\$ 1000 for each district, 12 International of up to \$5000 each).
- 3. Young Women in Public Affairs, established in 1990, 637 awards from 50 countries

Local Service Projects by different clubs are also undertaken by each club. Our KCMO II Club has sponsored Sheffield Place, a home for otherwise homeless women with children as they are provided shelter as they learn to get back to society with programs established for work and study. We have taken the mothers out for lunch and leisure (museum, play, library) and sponsored their Thanksgiving dinners for the past two years). We have fund raising activities as well to support the international funds for the programs and collaborate with others for support of CEDAW and violence against women. We are of course, always recruiting members (talk to me after the program).

#### In conclusion,

Zonta and International Women's Day as established by the United Nations have had strong ties in their history and thus it is appropriate to pay tribute to these two fine organizations that have made a difference in women's lives around the world. Here's to all the women who made these all possible, but more work needs to be done. The challenges are still before us in this increasingly complex world.

# **Advocacy**

As many of you will recall, the December 2012 issue of the Zonta e-newsletter featured an Advocacy Alert addressed to all US Zontians that 1. highlighted the essential features of the revised Violence Against Women Act that had passed the United States Senate but that was stalled in US House of Representatives and 2. asked US Zontians to write their representatives and urge them to reauthorize the revised act immediately. Although this advocacy initiative was sponsored by almost all American women's organizations, the effort was unsuccessful. The 112 Congress adjourned without bringing the VAWA to the floor for a vote. Some District 7 Zontians and Zonta Clubs may have acted on the ZI VAWA Advocacy effort that was initiated in the international e-newsletter, however, we will not know until Governor Janet Kannard receives the District Club reports.

Fortunately, the bipartisan sponsors of the revised VAWA remained committed to their goal and on January 23, 2013 the act was reintroduced in the Senate and rapidly passed. Once again, anticipating that there would be resistance to the VAWA in the House, the Zonta International Advocacy committee sent out a VAWA Advocacy Alert to District Advocacy Chairs in the United States to be forwarded directly to their respective clubs by email. Shortly thereafter, when it became clear that - in a attempt to stall and possibly defeat the Senate Bill - the House Republicans intended to put forward a significantly weaker version of VAWA, the ZI Advocacy Committee followed up with an urgent Call to Action, asking Zontians to call or write their Congressmen and demand that they set aside the weaker version of VAWA and vote to approve the version that had been passed by the Senate.

Unfortunately, the movement of bills through the US Congress is very difficult to track. Frequently, bills are brought to the floor with little or no advance warning. This happened in the case of the VAWA. Advocacy chairs received the Call to Action less than 24 hours before the vote was taken. Consequently, it is difficult to assess, just how many US Zontians were actually able to call or email their congressmen before the vote came to the floor. This said, a couple of our clubs in District 7 reported back that some of their members did receive the information in time and did make the call.

Congratulations to everyone who responded so quickly to the VAWA Action Alert. Every single voice counts, and as you know, this time the Advocacy effort was successful and the VAWA that had passed the Senate also passed the House.

During the next few months, the ZI Advocacy

Committee will be reviewing the procedures that were followed throughout the VAWA Advocacy Initiative with the goal of streamlining the advocacy process so that in the future, when important issues come up, alerts and calls to action are disseminated in a more timely manner. In addition, we will be developing a simple procedure that can be used to evaluate the effectiveness of future initiatives.
